Health History and Information Form

To assist us in providing for the health of your child please complete the **Health History and Information Form** as accurately and completely as possible for each child. An important portion of the health history is the immunization record. It is essential that this section be as complete as possible, especially the date of the last tetanus shot. The health care staff will review this form at registration. Please Note: <u>It is not necessary for a camper to have a</u> <u>physical prior to coming to camp, but it is encouraged</u>. A copy of a physical within the past <u>12 months may be attached if available</u>. The information on your child's health form will be kept confidential beyond the core staff necessary to make decisions regarding the health of your child.

It is our assumption that campers taking medication for mental health reasons have been on the same medication at the same dose for the three months prior to their camp arrival. If this is NOT the case for your camper, please call and talk with Shannon Kahler, Executive Director at 419 846-3010. Please do not plan to send your child to camp without medications normally taken for mental health reasons, we do not have licensed personnel on staff to properly care for children who are withdrawing from medications.

In an effort to protect campers from unauthorized use of medications, **all medications**, both prescribed and over-the-counter, are **turned in to the health care staff** at registration. The health care staff dispenses medications according to written instructions on the containers. <u>Please send your child's medications in their original packaging so the physician's directions are available.</u>

Please note, a camper will not be accepted for a camp if a communicable disease, Covid-19 symptoms, Influenza-Like Illness symptoms, or other compromising health condition is present (see enclosed Health Screening policy).

Over-The-Counter Medications Form

Inspiration Hills is authorized by standing orders from our physician to use a variety of overthe-counter medications. **The Over-The-Counter Medications Form** lists those medications. A parent's signature is necessary for those items to be dispensed by our health care staff.

Pick-Up Authorization

In an effort to provide for the safety of your child we have provided a **Pick-up Authorization** for your use. This is found on the bottom of your confirmation letter. It needs to be completed for each child before you leave camp on the day of registration. **You or the person picking up your child will be asked to sign the form again at the time of pick-up.** This form is also needed for any daily departures that may be necessary.

Additional Information

INSURANCE

Please provide the insurance information requested on the front page of the **Health History Form** and attach a photocopy of your insurance card to the form. Your family's health insurance will be the first insurance used to cover the cost of any necessary medical treatment for your child during camp.

ARRIVAL AT CAMP

Your confirmation letter will advise you of the time for registration. In an effort to limit exposure to A-symptomatic people, we ask that only one person bring your camper to camp this year. If other people are present we would like them to remain in the car. Temp checks and Covid-19 questionnaire will be done upon entering the camp, please remain in your car until you are sent to the check in area in the camp pavilion. Observe parking instructions and use appropriate safety precautions when driving through the camp. **Watch for children at play!**

REGISTRATION

Registration will be held in the camp pavilion. You can leave your camper's luggage in your vehicle until registration is complete. As a reminder, at registration you will need the completed **Health History and Information Form, Over-The-Counter Medication Form, and Pick-up Authorization** found in your confirmation letter. Your cooperation is necessary to make registration move smoothly.
